#### **New Business**

# Sheila Hunt to address the council about city's water

Mrs. Hunt addressed the council with concern that her water Pisgah Road smells like dirt and tastes like dirt. Johnny Hart presented a sample of water from her outside spigot to the council to

smell or taste if they chose to, no one voiced their opinion on the smell. Also, Johnny told her she may need to check her filter systems on the fridge. The mayor stated that they have not had any complaints recently about the same issues that she was having. The mayor also advised that maybe the hot water tanks may need to be drained and refilled. Mrs. Hunt did state that she knows when the lake turns over that it may causes changes to the water but hers still is bad. Johnny Hart also presented a written email from Mark Jones who is with the Arkansas Department of Health to the council and gave Mrs. Hunt a copy stating that City of Pottsville Water Works is in compliance with Revised Total Coliform Rule and Lead and Copper Rule. Not on agenda

The mayor stated that he had talked to the Highway Department, and they are going to start paving Pisgah Road in June when the school is out. They are fixing to start in May fixing patches and overlaying on 247, Pine Ridge and 363 going toward Crow mountain. He had asked the highway department about getting the turning lane across the Jordans gas station and was told they will see what they can do.

The mayor informed that the Easter Egg hunt will be Saturday 30th at Potts Inn.

The mayor stated that the city's Audit was done and that there were no findings, and all council members will be receiving a letter informing them of no findings.

Pam Scarber asked what the statues of the portable potties were, and the mayor told them that he has 6 coming from Murdock's to use during the April 8<sup>th</sup> eclipse.
