#### ORDINANCE NO. 2021-2

# AN ORDINANCE AMENDING TITLE 10 OF THE POTTSVILLE MUNICIPAL CODE FOR THE CITY OF POTTSVILLE ARKANSAS; AND, FOR OTHER PURPOSES

**WHEREAS**, there is a proposed amendment to Title 10, of the Pottsville Municipal Code which covers "Water and Sewer";

**WHEREAS**, the proposed amendment is attached to this Ordinance as "Exhibit A" and is incorporated in this Ordinance by reference; and

**WHEREAS**, the City Council has determined to approve the amendment in "Exhibit A," and amend Title 10 of the Pottsville Municipal Code.

## NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF POTTSVILLE, ARKANSAS:

**SECTION 1:** Title 10 of the Pottsville Municipal Code for the City of Pottsville, Arkansas is hereby amended to incorporate the amendment which is attached to this Ordinance as "Exhibit A" and incorporated herein by reference.

**SECTION 2:** Title 10 of the Pottsville Municipal Code for the City of Pottsville, Arkansas shall be amended only to the extent necessary to incorporate the attached amendment into the current Pottsville Municipal Code.

**SECTION 3:** In exercising the authority to codify the amendment attached as "Exhibit A," the City Council makes the following changes to the amendment attached as "Exhibit A" to:

- (a) Correct the spelling of words;
- (b) Change capitalization for the purpose of uniformity;
- (c) Correct manifest typographical and grammatical errors;
- (d) Correct manifest errors in references to laws, ordinances, and other documents;
- (e) Correct manifest errors in internal reference numbers, letters, and sections;
- (f) Correct punctuation;
- (g) Add provisions to reflect current ordinance; and
- (h) Remove provisions that have been revoked by ordinance.

**SECTION 4:** Any and all prior resolutions, ordinances, or parts of the same, which are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

**SECTION 5:** If any provision of this ordinance or the application thereof to any person or circumstances is declared to be invalid, such invalidity shall not affect the other provisions or applications of the ordinance which may be given effect without the invalid provision(s) or application(s), and to this end the provisions of this ordinance are declared severable.

**SECTION 6: EMERGENCY CLAUSE:** In order to correct an error in Title 10 in the Pottsville Municipal Code for the City of Pottsville and to provide accurate information to the citizens and accurately apply the ordinances as intended and in turn protect the health, safety, and welfare of the City and residents of the City of Pottsville, Arkansas, an emergency is declared to exist and this Ordinance shall go into effect immediately upon and after passage by the City Council.
